Re: Association versus cause

Epidemiology is about relationships, not proofs. Proofs are hard to come by.

The warning on cigarettes issued in 1969 by the Surgeon General was

The Surgeon General has determined that cigarette smoking is dangerous to your health
but does smoking cause disease? The presumption is it does, but proving it does is another matter.

In a previous posting I wrote about my contribution to Rachel Carlson's **Silent Spring**. Her writing was largely responsible for removing DDT (dichloro-diphenyl-trichloroethane) from the market without definitive proof of harm and misgivings about the decision (9 June 2022; More counting at Cal Pac).

In 1834 William Love started digging a canal to link the upper and lower Niagara River, bypassing the Falls. The water flow down the escarpment, in Love's scheme was to power the industry of a new "Model City" — but the invention of alternating current and practical power transmission torpedoed the scheme with only 3,200 feet of canal dug (Wikipedia).

In early 1900 the canal was used as a dump by the city of Niagara Falls. Subsequently, the canal was purchased by the Hooker Chemical Company (1947) for use as a dump site for byproducts from its manufacturing plant.

A fifteen-acre tract of land along the canal was residential, ultimately consisting of about 800 single-family homes. Over the years residents complained of seepage of foul liquids into basements. Ultimately the houses were bulldozed and land cleared (2004).

And there is the film "Erin Brockovich" about her quest to hold PG&E responsible for water pollution. The closing scene with Ed Masry (Albert Finney) is priceless.

Masry's closing line "Do they teach beauty queens how to apologize? Because you suck at it!" as he hands Erin Brockovich a check for much more than she had asked for (Erin's Big Bonus - Erin Brockovich UTube Movie clip).

Now it is Camp Lejeune's toxic water.
