

Re: The posting of results on ClinicalTrials.gov

Section 801 of the Food and Drug Administration Amendments Act (FDAAA 801) of 2007 included requirements for reporting results of drug trials on <u>ClinicalTrials.gov</u> within one year of completion. Failure to comply can result in sizeable fines.

The reporting requirement became effective for trials started or ongoing 27 September 2007. The requirement applies to:

Phase 2, 3, and 4 drug trials;

Studies involving drugs, biological products, and medical devices regulated by the FDA; and

Studies having at least one site in the United States or are conducted under an investigational new drug application or investigational device exemption.

So how is the trialist enterprise doing in complying with the requirement?

Not so good.

Slightly less than half of industry-funded phase 2, 3, and 4 drug trials and just 27% of NIH-funded drug trials completed in 2009 had results posted as of March 2015 dataset (Table 1).

The percentage of postings taking place within one year of completion is shown in Table 2. Less than half of the postings for industry-funded drug trials and just 20% of NIH-funded drug trials completed in 2009 had results posted within one year of completion.
