Over this run, there have been 27 subject matter memos, 5 homework assignments, three oath statements (table maker's oath, table master's oath, and document master's oath), a glossary worksheet, and a table and document specification worksheet.

Now for the "cut the grass" blow (Sleepy Eye talk for coup de grâce). A final exam! (If you want the key, return your completed exam to Watson).

The fetish represented by these memos is, no doubt, the lingering effect of having created, years back, a "document system" that quickly, in the corridors of the Center, came to be called HGDS – sanitized shorthand for "His God Damn System". (Historical note: Being confronted with the corridor name, I was faced with having to retrofit a name consistent with its corridor acronym. Hence, was born the **Heterogeneous Generic Document System**.)

I finish as I started, by reiterating that tables are our most important product. In people, we know that looks are only skin deep, but looks are everything when it comes to tables.

Of all the parts of a table, there is none more important than the title and column headers. As in most things written, generally less is more. Wordy titles and column headers are signs that the table maker was in a hurry.

If a table title is more than two lines in length it is too long and in need of iteration or indicative of "too many pigs under the same blanket".

The best titles are short and succinct and devoid of superfluous words. For certain, when constructing titles and column headers, it is useful to remember what Winston Churchill said: "Short words are the best and old words when short are best of all".
